## 二、 修業期限 Years of Study

(一)、碩士班:2至4年

2-Year Master: 2-4 years

(二)、四技學士班:4至6年

4-Year Bachelor: 4-6 years

(三)、二技學士班:2至4年

2-Year Bachelor: 2-4 years

#### 三、 申請資格 Eligibility

(一)申請資格係依據教育部《外國學生來臺就學辦法》所規定。辦法如經修正,將以教育部公告為準。有關辦法之最新訊息,請洽詢中華民國教育部。

The application qualification is in accordance with the "Law for Foreign Students Studying in Taiwan" published by MOE. Please contact MOE for latest information.

(二) 具外國國籍且未曾具有中華民國國籍,於申請時並不具僑生資格者。

Those who have foreign nationality and have never held R.O.C. nationality and also who do not possess overseas Chinese student status at the time of their applications.

- (三) 具外國國籍且符合下列規定,於申請時並已連續居留海外(不含香港、澳門及大陸地區)六年以上者(計算至8月1日且每曆年在臺灣停留時間不超過120日)並符合下列規定者: Those who hold foreign nationality have continuously resided overseas (other than Hong Kong, Macau, and Mainland China) over six years, have not stayed in Taiwan for more than 120 days each calendar year in the last six years, and comply with the following requirements:
  - 1.申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。

Those who hold R.O.C. nationality besides a foreign nationality have never registered a household in Taiwan when submitting application.

2.申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪失中華 民國國籍之日起至申請時已滿八年。

Those who once held R.O.C. nationality besides a foreign nationality have no longer held R.O.C. nationality for more than eight years since the status was revoked by the Ministry of Interior, R.O.C.

- 3.前二款均未曾以僑生身分在臺就學,且未於當學年度接受海外聯合招生委員會分發。
  Those aforementioned applicants have not studied in Taiwan with the status of Overseas Chinese Student, and have not accepted the assignment advised by the University Entrance Committee for Overseas Chinese Students.
- 4.依教育合作協議,由外國政府、機構或學校遊薦來臺就學之外國國民,其自始未曾在臺設有 戶籍者,經主管教育行政機關核准,得不受前二項規定之限制。

Those foreign students recommended by foreign government, institute, or school per educational agreement, who never registered a household in Taiwan would not be bounded by the aforementioned items if approved by the administration governing education.

- 5.符合下列情形之一且具相關證明文件者,不在此限;其在國內停留期間,不併入海外居留期間計算:
  - (1)就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
  - (2)就讀教育部核准得招收外國學生之各大專校院華語文中心,合計未滿二年。
  - (3)交換學生,其交換期間合計未滿二年。
  - (4)經中央目的事業主管機關許可來臺實習,實習期間合計未滿二年。

具外國國籍並兼具中華民國國籍,且於外國學生來臺就學辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者,得依原規定申請入學,不受第二項規定之限制。

Those who comply with one of the following items with approval document are not bounded, and the duration of staying in Taiwan will not be counted for overseas residence:

- (1) Attending overseas youth training courses that was organized by Overseas Compatriot Affairs Council or recognized by MOE;
- (2) Attending a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry, and in which the total length of stay is less than 2 years;
- (3) Exchange students, whose length of total exchange is less than 2 years;
- (4) The total duration of an Internship in Taiwan that has been approved by an authorized central government agency was less than two years.

An individual, who has both foreign and R.O.C. nationalities and has applied for an annulment of his/her R.O.C. nationality before February 1st, 2011, the effective date of this amendment, is then qualified to apply for admission under the original regulation as an international student and is not subject to the limitation as prescribed in Paragraph 2.

6.具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或海外(不含大陸地區)連續居留滿六年以上(計算至8月1日且每曆年在臺灣停留時間不超過120日)。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao or another foreign country (excluding Mainland China) for no less than 6 years prior to August 1st and whose stays in Taiwan per calendar year do not exceed a total of 120 days is qualified to apply for admission under these regulations.

7.曾為大陸地區人民且具外國國籍,且未曾在臺設有戶籍,申請時已連續居留海外(不含香港、澳門及大陸地區)六年以上(計算至8月1日且每曆年在臺灣停留時間不超過120日)。
An applicant being a former citizen of Mainland China and holding a foreign nationality, having no history of a household registration record in Taiwan, and at the time of application, who has

no history of a household registration record in Taiwan, and at the time of application, who has resided overseas (excluding Hong Kong, Macau and Mainland China) continuously for no less than 6 years prior to August 1st, and who stays in Taiwan per calendar year do not exceed a total of 120 days is qualified to apply for admission under these regulations.

#### (四) 學歷(力) Educational Background

1.外國學生須符合教育部採認之高中、大學或獨立學院畢業者(請參考教育部國際及兩岸教育司網頁 https://depart.moe.edu.tw/ed2500/),外國學生具高中畢業資格者,得申請入學本校學士班;於大專校院修習80學分者,得申請二技學士班;具學士學位者或具有與我國學制相當之同等學力資格者,得申請入學本校碩士班。

International students who have graduated from a high school, college or university recognized by the Ministry of Education of the Republic of China can apply for admission (for more information, please visit: http://www.edu.tw/bicer/). Applicants with a foreign high school diploma are eligible to apply for undergraduate programs; Applicants for 2-Year Bachelor Degree Program must have completed at least 80 credit hours in a college; Applicants with a Bachelor's or a Master's degree are eligible to apply for Master programs.

- 2. 具有教育部「入學大學同等學力標準」與我國學制相當之同等學力資格者。
  The applicants have the qualification to be equivalent to the academic qualifications of Taiwan's academic system based on "Equivalent Education Level for University Admission" regulated by Ministry of Education.
- (五) 相關規定:本校教學以中文為主,申請人應具備中文聽、說、讀、寫能力。

Relevant Regulation: Teaching in our school is mainly in Chinese, applicants should have sufficient listening, speaking, reading and writing ability in Chinese language.

(六) 語言能力門檻要求:母語非華語者提供國家華語測驗委員會華語能力檢定、其他同等級之華語測驗聽力與閱讀通過證明(等同於 A2級(含)以上),母語為華語者得免檢附。
Language Proficiency Threshold Requirements: Non-Chinese native speakers provide the
Chinese Language Proficiency Test of the National Chinese Language Testing Committee
Proof of passing the listening and reading test of other Chinese language tests of the same level
(equivalent to A2 level (inclusive) or above), Those whose mother tongue is Chinese are exempt
from submission.

- (二)繳交申請資料:備齊應繳文件後,請將資料掃描,寄至本校電子信箱。 Submit the Application File: After preparing the required documents, please scan the documents and send them by e-mail (tumticsa@gmail.com).
- (三)報名費用:免收報名費。

Application Fee: No application fee is required.

  - (3) 應屆畢業生申請時若尚未取得畢業證書可不必繳交,但須繳交學生證或「在學證明書」或「預計畢業證明書」。如經錄取,於錄取後辦理報到時,須繳驗學歷證件(畢業證書及成績單)正本,資格不符規定者取消錄取資格。

Recent graduates should submit a proof of studying, student ID card or official Certificate of Expected Graduation with their application. The original diploma and transcripts should be submitted at the time of registration or the admissions offer will be revoked.

- 7. 外國學生入學授權查證同意書(附件七) Authorization Statement-Form 7
- 8. 申請者需提供足夠在臺就學之存款證明或財力證明,至少 USD\$3,000(NTD\$100,000) 以上。如存款證明非申請者帳戶,需檢附資助者簽名之財力保證書並敘明兩者關係。 資助者僅限提供個人帳戶資料,不接受公司帳戶。

The applicant needs to provide the certificate of financial resources or proof of account balance statement (USD3,000 or NTD 100,000). If the bank account is the "Financial Guarantee" and declaring the relationship to the applicant. For sponsor's account, we only accept personal account.

#### 六、報到及註冊入學 Entry and Registration

- (一)錄取生應依入學通知書之規定日期辦理報到及到校註冊,註冊時應繳驗護照、學歷證明及成績單(均須經駐外館處或本校認定單位驗證蓋章),逾期未報到註冊者,取消入學資格。 The student should register by the date specified in the notice of enrollment. The passport, academic certificate and transcript should be submitted at the time of registration (both should be stamped and verified at the foreign office or stamped by the organizations authorized by TUMT). Overdue registration is not allowed, eligibility could be canceled.
- (二)註冊時應檢附自入境當日起至少六個月效期之醫療及傷害保險文件一份,此保險證明如為國外所核發者,應經駐外館處驗證。未投保者須強制繳納保險費,委由本校代辦投保事宜。已有臺灣地區「全民健康保險」者得出示健保證明。
  One copy of health and injury insurance document in effect for at least six months after entering the country. If the insurance certificate was issued by a foreign institute, it should be certified by R.O.C.'s Oversea embassies. Applicants who are not insured have to pay insurance fee mandatorily, and have the school process the insurance. Applicants with National Health Insurance have to submit their certificate of insurance.

  For matters relating to students' leaves of absence, duration of the term of study, graduation/total credit requirements, and credit waivers, please check with the Office of Academic Affairs or visit our website: www.tumt.edu.tw.
- (四)所繳入學相關證明文件,如有偽造、假借、冒用、塗改等情事,一經查明,取消其錄取資格、不准註冊;註冊入學後發現者,取消入學資格;已入學者開除學籍;畢業者,追繳已發之畢業證書。以上情節皆專案報教育部備查,本校並得送請司法機關追究其法律責任。 Applicants who have used false documents will have their admissions immediately cancelled and will be deprived of their student status as students of Taipei University of Marine Technology. If a violation is discovered after graduation, the degree will be cancelled and any certificates will be destroyed.
- (五)入學許可並不保證簽證取得,簽證須由我國駐外館處核給錄取學生來臺升學。
  The admission permit does not guarantee the visa. The visa must be approved by the Foreign Affairs Office.
- (六)獲准入學之學士班外國學生,到校時若已逾該學年度第一學期三分之一時程者,當學年度 不得入學。

An international student admitted to a university for registration at the time beyond one-third of the first semester of the current school year shall register for the second semester or the next school year

#### 八、獎助學金資訊 Scholarship

- 1. 書籍費:外國學生在學學期間書籍費免費。 Cost for textbooks is free during the studying years.
- 2. 第一學年學期間及寒暑假免收住宿費。
  Dormitory fee is free for the first academic year, including winter and summer vacation.

#### 九、學雜費退費標準 Refund Criteria

- 1. 學生於註冊日(含)之前申請休、退學者,應免繳費;已收費者,全額退費。
  If students withdraw before registration, they do not need to pay any fees. If they have paid the fees, they will receive a total refund.
- 2. 學生於開學日(含)之後而未逾學期三分之一申請休、退學者,退還學雜費及其餘各費用總和之三分之二。
  - If a student withdraws within the six weeks of any semester, they shall receive two -third refund of payment.
- 學生於開學日(含)之後逾學期三分之一,而未逾學期三分之二申請休、退學者,退還學雜費及其餘各費用總和之三分之一。
  - If a student withdraws after the seven weeks of any semester, they shall receive one-third refund of payment.
- 4. 學生於開學日(含)之後逾學期三分之二申請休、退學者,所繳各項費用,不予退還。
  If a student withdraws after the twelve weeks of any semester, they shall receive no refund of payment.

## 十、申訴辦法 Complaint
